ON ELEVEN THIRTEEN LAST. [REDACTED] ADVISED THAT RRI IS PRIVATE
NON-PROFIT ORGANIZATION WITH APPROXIMATELY EIGHTY PERCENT
OF ITS RESEARCH PROJECTS UNDER FEDERAL CONTRACT.

ON ELEVEN THIRTEEN LAST, SPECIAL AGENT OF FBI
OBSERVED ANTI WAR DEMONSTRATION SPONSORED BY SESPA COMMENCE
AT TWELVE NOON IN FRONT OF RRI, EIGHTY WEST END AVE., NYC.
DEMONSTRATION WAS HELD TO PROTEST USE OF FACILITIES,
PERSONNEL AND FUNDS OF RRI IN CONDUCTING NUCLEAR WAR
RESEARCH PROJECTS. DEMONSTRATIONS CONSISTED OF TWENTY-TWO
INDIVIDUALS STANDING BEHIND POLICE BARRICADES AND HANDING
OUT LEAFLETS CONTAINING PLEDGE OF SCIENTISTS AND ENGINEERS
FOR NONPARTICIPATION IN WAR RESEARCH OR WEAPONS PRODUCTION.

AT TWELVE THIRTY PM DEMONSTRATORS PUBLICLY TOOK ABOVE PLEDGE. AT TWELVE FORTY PM, THREE DEMONSTRATORS POSITIONED THEMSELVES ON SIDEWALK IN FRONT OF ENTRANCE OF RRI AND BLOCKED EMPLOYEES FROM ENTERING BUILDING. THIS ACTION WAS CONSIDERED BY DEMONSTRATORS AS IMPLEMENTATION OF ABOVE PLEDGE THROUGH CIVIL DISOBEDIENCE. OFFICERS OF NYCPD IMMEDIATELY ARRESTED THESE INDIVIDUALS ON CHARGE OF DISORDERLY CONDUCT AND BOOKED THEM AT TWENTIETH PCT. NYCPD.

DEMONSTRATION ENDED AT TWELVE FORTY-FIVE PM WITHOUT FURTHER INCIDENT. NONE OF DEMONSTRATORS WERE PERMITTED TO ENTER BUILDING. ALL DEMONSTRATORS WERE WHITE AND MOST WERE YOUNG ADULTS.
